

Terms & Conditions of the "Lucky Cat" Rock-West Trader Contest

1. General Provisions

1.1. The **Lucky Cat Trading Contest** (hereinafter referred to as the "Contest") is organized by **Rock-West (Maiv Ltd.)**.

1.2. Participation in the Contest implies acceptance of these **Terms & Conditions**.

1.3. The Contest is available **worldwide** (unless prohibited by local laws).

1.4. The official language of the Contest is **English**.

2. Contest Duration

2.1. The Contest runs from **February 10, 2025, to March 2, 2025**.

2.2. It includes **weekly competitions**, with winners determined each week.

2.3. At the end of the month, **final results** are summarized, and **grand prize** are awarded.

3. Participation and Registration

3.1. To participate, you must:

- Register at <https://portal.rock-west.com>.
- Open a **standard trading account** (other account types are not allowed) or be an existing RW standard trading account customer.
- Trade **at least 5 Lots** during the Contest period. (**February 10, 2025, to March 2, 2025**)

3.2. Only **one trading account per participant** is allowed. Using multiple accounts will result in disqualification.

3.3. Employees of **Rock-West (Maiv Ltd.)** and their immediate family members **are not eligible** to participate.

4. Contest Rules

4.1. Winners are determined based on **the highest percentage increase in account balance** each week.

4.2. **Weekly rankings reset** at the beginning of each new week.

4.3. The use of **trading robots (EAs), arbitrage strategies, or manipulative tactics** is prohibited and will lead to disqualification.

4.4. Prizes **accumulate**, meaning a participant can win multiple times during the Contest period.

5. Prize Fund

5.1. Weekly Prizes

The top three traders with the highest percentage increase in balance at the end of the week will receive:

- **1st place:** \$300
- **2nd place:** \$200
- **3rd place:** \$100

5.2. Grand Prize (End of the Month)

The top 1 trader with the highest percentage growth over the entire Contest period will receive:

- **1st place:** \$1,000

6. Prize Crediting and Withdrawal Conditions

6.1. **All cash prizes will be credited** to the participant's trading account.

6.2. To withdraw prize funds, participants must complete **a minimum trading volume of 5 standard lots**.

7. Leaderboard and Winner Announcements

7.1. **The participant ranking is updated weekly** on the **Rock-West.com (Maiv Ltd.)** website.

7.2. Winners are announced weekly via:

- **Email notifications**
